NOTICE OF PROPERTY TAX INCREASE

The City of Commerce has tentatively adopted a millage rate which will require an increase in property taxes by 13.9 percent over the rollback rate. All concerned citizens are invited to a public hearing on this tax increase to be held at the Commerce Civic Center, located at 110 State Street, Commerce, GA on August 26, 2022 at 12:00 PM. Times and places of additional public hearings will also be held at the Commerce Civic Center located at 110 State Street, Commerce, GA on August 26, 2022 at 6:00 PM and September 6, 2022 at 6:00 PM.

This tentative increase will result in a millage rate of 4.360 mills, an increase of 0.532 mills over rollback rate. Without this tentative tax increase, the millage rate will be no more than 3.828 mills. The proposed tax increase for a home with a fair market value of \$175,000 is approximately \$36.18 a year and the proposed tax increase for non-homestead property with a fair market value of \$175,000 is approximately \$37.24 per year.
